## **Terms and Conditions**

1. Duly filled in Tender forms should accompany with DD for 1% of the total cost drawn in favour of K.S.F.E. Ltd payable at Thrissur towards EMD.
2. Last date to submit the Tender is 05.12.2008, 3:00PM and will be opened on the same day at 3:30 PM.
3. Samples of each item should be enclosed with the Tender.
4. The rates should be inclusive of all taxes and transportation charges.
5. The clothes should be cut into pieces in the prescribed measurement, and three/five pairs each packed in one sachet with distinguishable marking, and delivered at our Head office and Regional Offices at Thiruvananthapuram, Kollam, Kottayam, Ernakulam, Kozhikode and Kannur.
6. There may be slight changes in the quantity while issuing supply orders.
7. The items should be supplied within 30 days from the date of receipt of the supply order.
8. The company will pay no advances.
9. The Company will make payment on confirmation of satisfactory completion of delivery and any damaged items are to be replaced by the supplier immediately on notice.
10. On award of supply orders, an agreement should be executed in stamp paper worth Rs.50/- (Rupees fifty only) with the Company and a security deposit amounting to 5% of the total amount should be deposited. The same will be refunded after 3 months on getting satisfactory report regarding quality of the clothes from the Regional offices.
11. Non / delayed delivery of the items at the time stipulated would attract forfeiture of the security deposit amount.
12. The company reserves the right to accept/reject any tender without assigning any reasons whatsoever.
